Interfor Announces Additional Long Term Debt Financing US\$50 Million – 3.25% Notes Due 2030

INTERFOR CORPORATION ("Interfor" or the "Company") (TSX: IFP) today announced it has priced US\$50 million in long-term debt financing with Prudential Private Capital, which is in addition to the US\$50 million that was previously announced on February 18, 2020, for a total of US\$100 million. The additional senior secured notes will carry an annual interest rate of 3.25% and have a final maturity in 2030. The financing is expected to close during March and the proceeds will be used for general corporate purposes.

Following completion of the financing, Interfor's long-term debt will have a weighted average interest rate of 4.08% with maturities that are primarily in the years 2024-2030.
